Will of Thomas Clarke of Middle Barton husbandman 16 August 1720

to Mary my loving wife messuage or ten now in occupation of John Harris

and two yardlands of harable land and the shop barn and close thereto belonging and the Barne called and known by ye name of Dorns barne And Likewise Quiet and Peaceable passage to the brooke for water through Joseph Ashes backside to and from the said brooke when Need shall Require it during her Naturall Life and if Mary my said wife should live untill Joseph Ashes Lease be expired then that part of the backside formerly belonging to the house called Jelimans house shall Returne to Mary my said wife during her Naturall Life And Likewise To Mary one great Chest and the Linen in it and two trunks and all that is in them and also three beds and bedsteads with all that is belonging to them and all other houseold goods which I shall die posest of: Except two beds and besteads the Long table hereafter in this will expressed; But what houseald? goods Mary my said wife shall have in her possession when shee dyeth shee shall have full youse to dispose of them to whom soever shee Will

To my Daughter in Law Frances Egleston the wife of Thomas Egleston £10 but if Frances Egelstone should dy before my wife the £10 to be equally divided between Frances Egelstons Children

to John Hanwell my granson £5 within twelve months after my wife's decease

to Elizabeth Hanwell granddaughter £5

if either grandchild should dy before my wife then legacy to return to executor

to John Boddington my granson the bed and bedstead he now Lyeth on and with a pair of sheets and blankets after my decease

to Nicholas Merwin granson £5

after the decease of Mary my wife to Edward Clarke my sonne all that Messuage shop barn and close and two yardlands of arable land also to Edward that house and backside called Dornes house now in occ of Joseph Ash after my decease to Edward the bedstead I now ly in and one Joyne? Chest that standeth at the west End of ye Chamber over the ? roome or Loe Chamber so called And the Long table and frame with the forme belonging to it in the Loe Chamber son Edward to have all My waring Apparell
