Blacksmith do this twenty Eighth Day of October in the ninth Year of the Reigne of our
soveraigne Lord King George Anno Domini 1723 make and ordain this my last Will and
Testament in manner and forme following First I desire to render up my soul into the
Hands of Almighty God who gave it and my Body to the Earth in hopes of a joyfull
Resurrection therof unto Eternall Life thro' the all sufficient merits of my Saviour Jesus
Christ And as for my worldly Estate Goods and Chattels I give them as follows Imprimis I
give unto my Eldest Son Phillip one Shilling Item I give unto my Son John and to my three
Daughters namely Mary Anne and Joan each of them ten Pounds of lawfule Money of
England to be paid by my Executrix hereafter named at the end of one Year after the
decease of my wife Elizabeth And as for the House wherin I now live all my Debts
being first paid I do hereby give and dispose of the same together with the Malt House Shop and
all outhouses yards gardens and all other the Members and Appurtenances therof and thereabout
belonging or therewith now used and enjoyed to my Youngest Son Thomas whom I do constitute
and make and appoint to be the whole and sole Executrix of this my last Will and
Testament to gaiving yearly therofrom the sum of five Pounds of lawfule Money of England
unto my Deare wife Elizabeth during her naturall Life or else maintaining her in this my
House in every thing that is fitting and necessary according as her necessities require And as
for all Household Goods Shop Goods Utencells and working Tools of my Trade and all other

unto my dear wife Elizabeth during her natural life or else maintaining her in this my
House in every thing that is fitting and necessary according as her necessities require And as
for all Household Goods Shop Goods Utencils and working Tools of my Trade and all other
my goods and chattels I do hereby give and bequeath the same unto my said Son Thomas
Excepting the best Bed with every thing belonging to that Bed which I give unto my said Wife
during only her natural life and afterwards to return to my Son Thomas whom I would
have defray my Funeral charges) Item my will is of my Son Thomas shall not sell or
other ways dispose of my Dwelling House Malt House or Shop or any Outhouses gardens
or members and appurtenances therof without the free Consent of my Dear Wife first
obtained And furthermore my Will is that if my Son Thomas should die unmarried
my dear Wife Elizabeth surviving him & then she shall have and enjoy my House wherein
I now live together with the Malthouse Shop Yard garden and all Outhouses and
Appurtenances therunto belonging during only her natural life and afterwards to
devolve to my Son John and my three Daughters viz: Mary Ann and Joan to be equally
divided among them or the survivors of them at & Decesse of my said Wife Elizabeth Lastly
I hereby revoke and make void all former Wills by me heretofore made whatsoever In
Witness whereof I have hereunto sett my Hand and Seal & Day and Year first above
written — Phillip Evans — signed sealed published and delivered in the presence of

To Eldest Son Phillip one shilling

To his Son John and his three Daughters Mary Ann and Joan each of them ten Pounds to be paid by Executor at the end of one Year after the death of his Wife Elizabeth

And as for the House wherein he now lives he gives this with Malt House Shop and Outhouses Yards Gardens to his youngest Son Thomas who is to pay yearly £5 to his Wife Elizabeth during her natural Life or else maintaining her in this his House in everything that is fitting and necessary

To Son Thomas all Household Goods Shop Goods Utencells and working Tools of his Trade and all other Goods and Chattels Excepting the Best Bed with everything belonging to that Bed which he gives to his Wife and after her her death to his Son Thomas

Thomas not to sell or dispose of Dwelling House Malt House or Shop without the free consent of his Wife Elizabeth

If Thomas dies unmarried his Wife Elizabeth is to have House Malt House Shop and after her death to go to Son John and three Daughters Mary Ann and Joan to be equally divided between them or their survivors

His son Thomas to be sole Executor

Will of Thomas Evans WB Blacksmith 12 October 1773

To his Wife Elizabeth House Malt House Barn Stable Gardens and Backside in WB now in his posession with all his Furniture of household Goods household stuff plate and Linnen in said House After his Wife's death or second marriage to Son Rowles Evans and after his death to his lawful issue for ever the above mentioned House Malthouse Barn Stable subject to the payment of £40 to each of his three Daughters Ann Elizabeth and Mary This estate is subject to the payment of the said sum of £140 and in default of such issue this estate will, after the death of Rowles Evans, go to his Daughters Ann Elizabeth and Mary or to their lawful issue

To Son Rowles and three Daughters after the death or second marriage of his Wife the before mentioned Household Goods and Linnen to be divided amongst them equally

To his Wife Elizabeth during her natural life or second marriage his House Close and Garden in MB lately bought of Joseph Ash and Thomas Danderidge now in tenure of Thomas Ryman

After his Wife's death or second marriage that House to his eldest Daughter Ann and her heirs

To his Wife Elizabeth the Use or Interest of £500

After her death the £500 to Son Rowles and his three Daughters Ann Elizabeth and Mary in equal shares

To his Wife Elizabeth his stock of Malt in the Malt House

To his Son Rowles the Blacksmith's Shop in WB now in his [Thomas's] own occupation with all Implements of working tools in the Shop

His Wife Elizabeth and his trusty and faithfull friends John Buswell of WB commonly called John Buswell at Pound and his Trusty Friend John Hollis of WB appointed trustees for his four children Residue to his Son and three Daughters share and share alike

To John Buswell and to John Hollis £1 1s each to buy a Ring

His Wife Elizabeth to be sole Executrix



 Blacksmith and being in good Health of body and of perfect good Memory and Understanding I
 praise God for the same I do hereby make and ordain this my last Will and Testament in manner
 following (that is to say) First I command my Soul to Almighty God that gave it in hopes of a
 Forgiveness for all my Sins through the Merits and Intercessions of my blessed Redeemer Jesus Christ
 and my Body to be decently buried by my Executrix hereinafter mentioned and as for my temporal
 and worldly Estate which it hath pleased Almighty God to bless me with I give and bequeath in a
 manner following Item first I will that all my just Debts and Funeral Expenses be paid and
 satisfied by my Executrix hereinafter mentioned Item I give and bequeath unto my beloved Wife
 Elizabeth Evans for and during the Term of her natural Life or second Marriage All that my House
 or Tenement Malt House Barn Stable Gardens and Backside with all Appurtenances thereto belonging
 or in any wise appertaining now in my own Possession and being in Wockott Barton in the County of
 Oxford aforesaid together with all my Furniture of household Goods household stuff plate and Linen
 in the said House is contained and from and after the decease of my said Wife Elizabeth or her second
 Marriage which shall first happen I give unto my son Rowles Evans All that my before mentioned House
 or Tenement Malt House Barn Stable Garden and Backside with all Appurtenances as aforesaid thereto
 belonging in Wockott Barton aforesaid and to the Issue of my son Rowles Evans lawfully begotten and
 which shall be living at the time of the Decease of my son Rowles Evans for ever subject nevertheless
 to the Payment of Forty Pounds of lawful Money per annum to each of my three Daughters (that
 is to say) Ann Elizabeth and Mary which aforesaid Estate with all Appurtenances I subject to the

wife Elizabeth Evans or her second Marriage I give all that my last mentioned House Close and
Garden with all Appurtenances thereto belonging and in Middle Barton aforesaid unto my Eldest
(Daughter Ann Evans to her and her Heirs for ever Item I give unto my beloved Wife Elizabeth for
and during the Term of her natural Life or second Marriage All that my Due or Interest of the
principal Sum of five hundred Pounds without Impeachment or Impoachement of Waste of any of
the principal Sum of five hundred Pounds Except Interest only and from and after the death of my
said wife Elizabeth or her second Marriage I give the aforesaid Sum of five hundred Pounds of
lawful Money unto my Son Rowles Evans and my three Daughters Ann Elizabeth and Mary

in equal shares share and share alike I then I give to my beloved wife Elizabeth all that my stock
of Malt which shall be in the Malthouse at the time of my Decrease I then I give unto my son -
Rowles all that my Blacksmiths shop standing and being in Westcott Barton now in my said
Occupation together with all Implements of working tools in the said Shop I then I give unto my
Wife Elizabeth and my trusty and faithfull friends John Buswell of Westcott Barton commonly
called John Buswell at Pound and my Trusty Friend John Hollis of Westcott Barton aforesaid
whom I do hereby and to this my last Will appoint and ordain in full Trust for the use and
trust for my four Children Rowles Ann Elizabeth and Mary and to and for no other Two
or persons whatsoever All other my Bills Bonds Debts Book Debts and all Money any way
due to me at my Decrease Except what is before mentioned and I will and give full power to my
said Wife and my said Trusty Friends John Buswell and John Hollis hereby assigned to sue and
recover and receive all my Bills Bonds and Debts Book Debts and all Money any way due to
me at my decease Except what is before excepted and therewith to pay all my just Debts
and funeral Expenses and after my just Debts and funeral Expenses is paid and satisfied
or at most within two Years after my decease then the rest and residue of all Money remaining
I will to be paid to my Son Rowles and my three Daughters Ann Elizabeth and Mary share
and share alike I then I give to my said Trusty Friend John Buswell of Westcott Barton
commonly called John Buswell at Pound the sum of one Pound one Shilling to buy a Ring
I then I give to my said Trusty Friend John Hollis the sum of one Pound one Shilling to buy
a Ring And lastly I appoint and ordain my beloved wife Elizabeth Coates to be the full
whole and sole Executrix of this my last Will and Testament and I do hereby revoke disannul
and make void all former Will or Wills at any time heretofore by me made and I do make

a Ring And lastly I appoint and ordain my beloved wife Elizabeth Evans to be the full
whole and sole Executrix of this my last Will and Testament and I do hereby revoke disannul
and make void all former Will or Wills at any time heretofore by me made and I do make
and ordain this to be my last Will and Testament contained in two Sheets whereunto I

this twelveth day of October and in the Year of our Lord one thousand seven hundred and
