If William dies under age leaving no issue but leaving a widow Trustees to pay £500 to widow

If son dies and no widow then the sd £500 to my brothers and sister

Trustees shall, immediately after my decease place my son William Johnson with brother in law Richard Roach, sister Mary Roach or with brother Nathaniel Parsons for as long as they think fit and they shall be paid for board and lodging

if William dies without issue or widow one part of money to go to my niece Elizabeth Parsons, daughter of Nathaniel and the other moiety to the children of my sister Mary Roach divided equally

Nathaniel Parsons, Kiddington, yeoman, and heirs, real estate at Salford and elsewhere upon trust that he shall let and set the same or any part thereof or the utmost yearly rents that can be obtained and shall keep sd premises in proper repair and pay remaining profits to sd nephew William Pritchard and my niece Sarah, wife of sd Nathaniel Parsons equally until my nephew William Johnson, son of my late brother William Johnson, shall come to the age of 10 years and Nathaniel Parsons shall then secure rents and profits from estate for maintenance, education, bringing up and use and benefit of my nephew until he attains the age of 21. When he becomes 21 estate but if he dies to Nathaniel Parsons
